Erik Jones is Professor and Director of the Robert Schuman Centre for Advanced Studies at the European University Institute and Nonresident Scholar at Carnegie Europe. Professor Jones is author of *The Politics of Economic and Monetary Union* (2002), *Economic Adjustment and Political Transformation in Small States* (2008), *Weary Policeman: American Power in an Age of Austerity* (2012, with Dana H. Allin), and *The Year the European Crisis Ended* (2014). His latest book is a Cambridge 'element' called *From Club to Commons: Enlargement, Reform and Sustainability in European Integration* (2025, with Veronica Anghel). Professor Jones is editor or co-editor of more than thirty books and special issues of journals on topics related to European politics, political economy, and the transatlantic relationship, and he has been co-editor of *Government & Opposition* since 2015. Professor Jones' commentary has appeared in the *Financial Times*, *The New York Times*, and other major newspapers and magazines across Europe and North America.
